In 1967, the Florida Legislature founded Pasco-Hernando Community College as the 28th and final link in the state system of community colleges. After more than four decades of service, the College has conferred more than 35,000 degrees and certificates. Serving the community's need for higher education has fueled the College's growth and expansion, and in January 2014, the College transitioned to a state college—Pasco-Hernando State College. Campuses include Brooksville, Dade City, New Port Richey, Spring Hill and Porter Campus at Wiregrass Ranch. With more than 17,000 students, PHSC is recognized as a premier higher education institution.

PHSC prepares graduates to be job ready and success bound. Our programs train and educate students who go on to become the best and brightest teachers, local and state representatives, law enforcement officers, EMTs, dental assistants, nurses, paralegals, attorneys, computer programmers and business leaders.

Charitable Gift Annuity: A contribution can be used to set up a charitable gift that will pay income to annuitants. Payout rates are set by the American Council on Gift Annuities and are better than current CD rates.
